Scope of Journal

The *Journal of Applied Physiology* publishes original papers that deal with diverse areas of research in applied physiology, especially those papers emphasizing adaptive and integrative mechanisms. Adaptive physiology includes 1) inherent adaptations such as those related to development, aging, and pathophysiological conditions and 2) adaptations to the external environment such as those occurring with exercise, microgravity, hypoxia, hypo- and hyperbaria, and hypo- and hyperthermic conditions. Integrative physiology includes 1) horizontal integration across organ systems and 2) vertical integration from molecule to cell to organ. In all areas of applied physiology, the use of cutting-edge techniques including molecular and cellular biology is strongly encouraged.

The wide scientific span of the Journal rests on physiology as its keystone. However, the boundaries of physiology have enlarged as demarcations between concepts and techniques in the physiological, pharmacological, and biochemical sciences become increasingly blurred. Moreover, theoretical articles on research at any level of biological organization ranging from molecules to humans fall within the broad scope of the Journal. Papers dealing with topics in other basic sciences that impinge on physiology are also welcome.

- **CiteTrack:** Receive e-mail alerts when new content matches criteria based on the topics, authors, and articles you want to track.
- **eTOCs:** Free e-mail notification of new tables of contents as they become available.
- **RSS Feeds:** A mechanism to subscribe to "headlines" from a web site.
- **Manuscripts published online** within days of acceptance.
- **LOCKSS and CLOCKSS:** Perpetual/electronic archiving of the LOCKSS and CLOCKSS systems preserves the electronic content of all APS journals.
- **CrossRef:** APS participates in CrossRef initiative, which links to over 5,600 journals worldwide.
- **Legacy Content** is an online package of over 100 years of historical scientific research from 13 APS research journals.
- **AuthorChoice** Authors can choose to pay a fee on top of regular author fees and have their articles publicly available upon publication.

Article Types

RESEARCH ARTICLES: Peer-reviewed articles that present important new research results including the entire contents of a research project. Included are an abstract, an introduction, methods and results sections, a discussion, and relevant citations.

VIEWPOINT: Articles that are intended to present an insightful, thoroughly documented slant on a topic for which opinions are either controversial or undecided in the literature. In addition, brief commentary will be solicited from the readership. Some articles will be invited and unsolicited manuscripts are welcome.

POINT:COUNTERPOINT: This is a series of debates where contradictory viewpoints are put forward. This is a dialectic process whereby a thesis is advanced, then opposed by an antithesis, subsequently arriving at a synthesis. This approach differs markedly from the review article where the reader expects the author to present balanced coverage of the topic.

INNOVATIVE METHODOLOGY: Manuscripts submitted under this category should describe new methods for the recording, collection, and/or analysis of data relevant to understanding how the physiological system works.

REVIEW ARTICLES: Synthesis of state-of-the-art knowledge in a defined area highlighting new questions and pointing to future research directions. They encompass examination of biological processes, systems, and models, and technologies for their study. Typically, reviews are invited and all are peer-reviewed.

EDITORIALS: Provide commentary by the Editor, Associate Editors, and other scientists and experts on issues related to the Journal's mission as well as of general interest to our readers. Acceptance will reside with the editors.

INVITED EDITORIALS: Commentaries on papers of unusual interest published in the journal that were chosen by the Editor to be highlighted by a brief Invited Editorial commentary.

LETTERS TO THE EDITOR: Short letters reviewed by the appropriate editor and subject to editing and possible abridgment. They do not include original, unpublished data. They also address matters of general interest to the readership.
